As per guidelines prescribed by the MCA Circulars, physical copy of the Notice was not sent to the Members for this Postal Ballot and the approval of the Members was sought only by means of remote e- voting.

In accordance with the MCA Circulars and Listing Regulations, the Company had made necessary arrangements with Link Intime India Private Limited, its Registrar and Share Transfer Agent (herein after referred as "InstaVOte" /" RTA") as the agency to provide the e- voting facility.





The Postal Ballot Notice was sent to the Members whose names appeared in the List of Beneficial Owners received from National Securities Depository Limited ('NSDL') / Central Depository Services (India) Limited ('CDSL') ('Depositories') as at the close of business hours on Friday, October 20, 2023 ('Cut-Off Date') whose e-mail addresses were registered with the Company/RTA/Depositories.

The Company through its RTA uploaded the resolutions together with explanatory statement on which e-voting was sought from the Members in the website of RTA at <https://instavote.linkintime.co>. and also hosted the same on the website of the Company, <https://www.tvsscs.com>.

FURTHER, I REPORT THAT:

The Postal Ballot Notice dated October 20, 2023 were sent to 86,423 Members vide electronic mode to their email addresses and mobile numbers registered with the Depository Participants, as per the data downloaded from the NSDL/CDSL as on Friday, October 20, 2023. The Company has completed dispatch of Postal Ballot Notice through email on Monday, October 23, 2023.

The remote e-voting period commenced on **Thursday, October 26, 2023** 09:00 Hours (IST) and was closed on **Friday, November 24, 2023** at 17:00 Hours (IST) for the Members exercising their vote through electronic voting. The remote e-voting modules were disabled by "InstaVot" / "RTA" for voting thereafter. All votes cast by e-voting through "InstaVot" / "RTA" received upto **Friday, November 24, 2023** at 17:00 Hours (IST) being last date fixed by the Company for exercise of vote by electronic means, were considered for my scrutiny.

On scrutiny, I report that 144 Members had exercised their vote through electronic voting (E-voting). The voting was reckoned in proportion to the paid-up value of the shares mentioned against the name of the shareholder in the Register of the Members as on Friday, October 20, 2023.




