5. The voting period for remote e-voting commenced on Sunday, July 27, 2025 (09:00 hrs IST) and ended on Tuesday, July 29, 2025(17:00 hrs IST). The remote e-voting module was disabled by NSDL for voting thereafter.
6. The Unsecured Creditors meeting was convened on Wednesday, July 30, 2025 at 3:00 PM in accordance with the directions of the orders referred above through Webex. The quorum fixed for the meeting was 50 (fifty).
7. The Company has also provided e-voting facility for those Unsecured Creditors who had not cast their vote on the resolution earlier by availing the remote e-voting facility prior to the meeting. The remote e-voting module was kept open for voting for a period of 30 minutes after the conclusion of the meeting. Thereafter, the voting was blocked by me on the NSDL e-voting website at 3:50 P.M.
