**Day, Date, Time, and Venue of the Meeting:**

A Meeting of the equity shareholders of the TVS Supply Chain Solutions Limited ("Company") was convened today, Wednesday, the July 30, 2025 at 11.00 a.m. through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM"), pursuant to the order of Hon'ble National Company Law Tribunal, Chennai Bench ("NCLT" or "Hon'ble Tribunal") dated May 30, 2025 in CA(CAA)/31(CHE) 2025 ('Order').

**Proceedings in brief:**

- Mr. L N Gupta, former NCLT Member, appointed by the Hon'ble National Company Law Tribunal, Division Bench, Chennai ("Hon'ble Tribunal"), chaired the meeting ("Chairperson") of the equity shareholders of the Company. Upon confirmation of requisite quorum being present, the Chairperson called the meeting to order.
- Chairperson informed the equity shareholders that the meeting was being held through VC/OAVM, pursuant to the Order passed by the Hon'ble Tribunal and in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and the Securities and Exchange Board of India.
- At the request of Chairperson, Sri. R Dinesh, Executive Chairman, Sri. Ravi Viswanathan, Managing Director, Sri. Vaidhyanathan R, Global Chief Financial Officer (GCFO) and Sri. P D Krishna Prasad, Company Secretary, present at the meeting introduced themselves to the equity shareholders and welcomed them to the NCLT convened meeting.
- The Chairperson also provided various details to the equity shareholders with respect to availability of Notice and Explanatory Statement on the Company's website, remote e-voting, e-voting at the meeting. The equity shareholders were informed that pursuant to the Order of the Hon'ble Tribunal, Mr. F Raymond Albyness, Advocate, was appointed as the Scrutinizer to scrutinize the process of remote e-voting and e-voting at the meeting.
- The Chairperson addressed the equity shareholders present at the meeting and briefed them on the resolution approving the Scheme of Amalgamation between Mahogany Logistics Services Private Limited (formerly known as DRSR Logistics Services Private Limited), TVS SCS Global Freight Solutions Limited, White Data Systems India Private Limited, SPC International (India) Private Limited and FLEXOL Packaging (India) Limited with and into TVS Supply Chain Solutions Limited and their



shareholders, under Sections 230 to 232 and other applicable provisions of the Companies Act, 2013 ("Act").

- Subsequently, the Chairperson requested those shareholders who had registered to speak at the meeting and raise their questions, which were duly answered by the management team.
- The Chairperson informed the members that the Company had engaged National Securities Depository Limited ("NSDL") to facilitate e-voting before and during the meeting. The Chairperson further informed that remote e-voting opened on July 27, 2025 at 9.00 AM (IST) and ended on July 29, 2025 at 5.00 PM (IST). The e-voting on the resolution during the meeting was held for half an hour from 11:20 AM to 11:50 AM.
- Based on votes exercised by the equity shareholders of the Company by way of remote e-voting and voting at the Hon'ble NCLT convened meeting, Mr. Raymond Albyness F, the Scrutinizer has submitted the Consolidated Report dated July 30, 2025. The results will be displayed on the noticeboard, website of the Company, NSDL and will be announced to the Stock Exchanges.
- The Chairman thanked the members and declared the proceedings of the Hon'ble Tribunal meeting as closed and on completion of e-voting by members, the meeting was concluded at 11:50 a.m. (IST).

6. The Equity Shareholders meeting was convened on Wednesday, July 30, 2025 at 11:00 AM in accordance with the directions of the orders referred above through Webex. The quorum fixed for the meeting was 30 (thirty).

The Second Transferor Company, Third Transferor Company, Forth Transferor Company and Fifth Transferor Company are subsidiaries of the Company and are hereinafter collectively referred to as the "Subsidiaries". The proposed Scheme has been approved by the Board of Directors.
4. The Management is also responsible for ensuring that the Company complies with requirements of the Circular and the Proposed Scheme and provides all relevant information to the SEBI.

**Auditor's Responsibility**

5. Pursuant to the requirements of the Circular, our responsibility is to provide a limited assurance and conclude as to whether the attached Statement provides the reasons for non-applicability of Para 10(a) read with provisions of Para 10(b) of Part I of the Circular.

Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed. Accordingly, our procedures in relation to Statement include the following:
  - a. Obtained and read the reasons provided by the management of the Company in the attached Statement.
  - b. Obtained the management certified shareholding Pattern, list of Promoters and Promoter Group and related parties of Promoter Group as on December 31, 2023 and compared the same with the shareholding pattern as on December 31, 2023 filed by the Company with BSE Limited and National Stock Exchange of India Limited on January 18, 2024.
  - c. Inquired from the management whether additional shares have been or will be allotted under the Proposed Scheme to Promoter / Promoter Group, Related Parties of Promoter / Promoter Group, Associates of Promoter / Promoter Group, Subsidiary/(s) of Promoter / Promoter Group of the Company.
  - d. Obtained and read the Proposed Scheme, compared the same with the list provided in para 10(b) above and verified whether:
    - i. the Proposed Scheme involves additional shares allotment to Promoter / Promoter Group, Related Parties of Promoter / Promoter Group, Associates of Promoter / Promoter Group, Subsidiary/(s) of Promoter / Promoter Group of the listed entity.
    - ii. the Proposed Scheme involves the Company and any other entity involving Promoter / Promoter Group, Related Parties of Promoter / Promoter Group, Associates of Promoter / Promoter Group, Subsidiary/(s) of Promoter / Promoter Group.

Based on the procedures performed by us under paragraph 10 above, and according to information and explanations received and management representations obtained, nothing has come to our attention that causes us to believe that the attached Statement does not provide reasons for non-applicability of Para 10(a) read with provisions of Para 10(b) of Part I of the Circular.


